  - I wrote the design brief/s contained in each entry.
  - I was responsible for all design changes made during the design phase of the project/s.
  - I hold responsibility for all design documentation (drawings and specification).
  - I have obtained, and hold written permission, from the owner of the project/s to enter these awards and for any resulting publicity.
  - I have obtained, and hold written permission, from the photographer or copyright holder of the images supplied as part of this entry.
  - I give permission to KBDi to publish the images supplied with this entry on their website, social media pages, blogs, flyers and brochures, and within editorial provided to third parties.
  - I indemnify KBDi from any action, legal or otherwise, taken by any project owner, photographer, or any person or entity who has a claim to copyright in relation to any entry I submit in this competition.
